

EXPLANATORY STATEMENT UNDER SECTION 102 OF THE COMPANIES ACT 2013

In order to bring the Rules up to date with the present happenings and in order to remove certain lacunas in some of the Rules, certain amendments have become necessary.

Rules of the Company, as distinguished from the provisions of the Memorandum & Articles of Association, can be repealed, amended and replaced by new set of Rules by a special resolution of the Company in the General Meeting as stipulated in Paras 10,11 and 12 of the Articles of Association.

All the above amendments have been already approved by the Court. They are now being circulated to all the members for their consideration.

In the passing of this resolution, none of the members of the Court have directly or indirectly any pecuniary interest.

After completion of the AGM, Members are invited to interact and share their suggestions for the improvement & growth of the organization.

AMMENMENT TO RULES FOR CONSIDERATION AS SPECIAL RESOLUTION

CHAPTER RULES

1. Para 1(1) to be amended as follows:

The Company may establish local chapters where at least 15 members have their normal residence. The chapter shall carry on activities of the Company locally in accordance with these rules, especially contributing to the growth of the Company.

2. Para 1 (2) to be amended as follows:

"Enrolment: Fellow members, Members, and Associates shall be eligible to be members/associates of a Chapter. Sea going members/associates may opt to be associated with a chapter even if they are not ordinarily residents of such place. The Chapter shall submit a list of Members/Associates enrolled, to the Court along with its Annual Report.

3. Para 1(3) to be amended as follows:

"Members/Associates may change their membership/associateship from one chapter to another chapter by giving a notice of at least 15 days to each of the two chapters concerned & to CMMI head office.

4. Para 2(3) to delete

5. Para 2(6) to be amended to read as:

"Chapter s h all hold meetings on technical subjects or other topics of interest regularly. Report of each such meeting shall be submitted to the Court for information and as deemed fit for publication in the Company's "Command" journal.

6 Para 3(1) to be amended to read as:

"The chapter shall be the integral part of the Company of Master Mariners of India. The Court shall provide the chapter an imprest amount as decided by the court from time to time which shall be utilised towards its expenses for paper reading meetings, seminars, stationery, postage and other small incidental expenses. The imprest amount shall be renewed as and when considered necessary. However, in case a chapter proposes to hold an event in consultation with the court, then additional finance may be made available. Such proposal should be presented to the court well in advance for financial planning.

7 Para 3(3) to be amended to read as:

"The Chapter shall submit its annual report, including its activities and a statement of accounts within 30 days of the close of the year i.e. by the 30th April each year. Such statement of accounts shall show all the income & expenditure for the year.

MEMBERSHIP RULES

1. Rule 1(1) to be amended as follows:

"No person can be elected as an Associate, a Member, a Fellow Member, a Corporate Body or a Honorary Fellow unless he is an Indian national or of Indian origin and qualifies to be as under.

- 2. Rule 1(2) to be amended to read as:
 - a) "An "Associate " means a person holding at least A certificate of Competency as an officer-in-charge of a "Navigational Watch", issued by a Country accepted by the Court, or
 - b) A degree in "Nautical Science" from a university accepted by the Court, or
 - c) A certificate of Competency as a "Dredge Master" or as a Master of "Near Coastal Vessels" (NCV) or
 - d) Any other qualification considered equivalent to the above qualifications.
- Rule 1(3) to be amended to read as follows:

An existing "Student Associate" shall be termed as an "Associate".

4 Rule 2 to be amended as follows:

2. ELECTION OF MEMBERS AND ASSOCIATES

Rule 2(1); the word "student" to be deleted wherever it appears.

Rule 2(2): the word "student "to be deleted wherever it appears.

Rule 2(4): the word "student "to be deleted wherever it appears.

Rule 2(5): the word "student" to be deleted wherever it appears.

Rule 2(6): the word "student" to be deleted wherever it appears.

- 5 In Rules 3(1), 3(2) and 3(3) wherever the word "member" appears, it is to be amended to "Member/Associate "and word "membership" to be amended to Membership/Associateship"
- 6 In Rule 4- word "Members" to be amended to "members/associates".

- 7 Rule 5(1) to be amended to read as:
- (1) The structure of fees for Associates and Members would be as follows.
- (a) Associate

Entrance Fee – Rs.3, 000/

Membership fee_ Rs 2,000/-

In rest of this sub-rule the word "student" to be deleted wherever it appears.

(b) Member

Entrance fee - Rs 3.000/

Life Membership fee – Rs.12, 000/-

8 Sub rule 7(2) to be amended to read as below:

"The Court shall have power to suspend or, to cancel the membership of any member whose conduct, in the opinion of the majority of the Court, is detrimental to the interest of the Company or renders him unfit for membership of the Company provided, majority of the wardens, not being less than 10, vote for the resolution at a meeting of the Court.

9 Sub rule 7(3) to be amended to read as below:

"There shall be given to the member at least fourteen days' notice of such meeting, or such longer notice as under the circumstances of the case will give him a reasonable opportunity of appearing before the Court. Every such notice shall clearly state the complaint about the member. After hearing the member, if the Court finds that the charges are justified, his membership will be terminated or suspended for a given period, At such hearing, majority of the wardens, not being less than 10, must vote for the resolution at a meeting of the Court.

COURT RULES

- 1. Sub Rule 1(1)(f) to be replaced by "6 wardens co-opted from chapter chairmen, members at sea and persons whose participation is considered desirable by the Court"
- 2. Sub Rule 1(1)(g) to be deleted
- 3. Sub Rule 2(3) to be deleted
- 4 Sub rule 2(5) to be amended to read as follows:

The election shall be by postal, electronic media or by such other means of voting as the Court shall from time to time decide. The entire election process should complete latest by second week of September in that year

5 Sub rule 2(6) to be amended to read as follows:

"In every such election, a Member or a Fellow shall have one vote for each vacancy. The Associates and Honorary Fellows are not eligible to take part in this election process.

6 Following Rule 2(7) (a) to be inserted.

"During the election process for wardens, if 2 or more contestants at the lowest rung get equal number of votes, then the matter will be resolved by carrying out a lucky draw. This lucky draw will be carried out during the Court meeting in which the election results are to be announced. The lucky draw will be carried out by the Returning Officer in the presence of all the wardens present at that meeting.

7 Sub rule 2(8) to be amended to read as follows:

"Upon the Court accepting the results, the result of the voting shall be announced in the media (or other available means) and same should be informed at the Annual General Meeting of the Company in that year.

8 Sub Rule 2(10) to be amended to read as:

"The tenure of the Court shall end when the newly elected Court holds its first meeting which shall take place any time after the AGM of that year, but not later than 1st week of October in that year, in any case."

9 Sub rule 2(11) to be amended as follows:

"The first meeting of the new Court shall be held in the first week of October in that year At the first meeting of the new Court which a Warden attends, he shall make the declaration as stated in Annexure to these Court Rules.

10 Rule 3 to be amended to read as:

"Regarding procedure for inclusion of co-opted wardens in the Court, please refer to Article 6 of the Articles of Association of the Company."

11 Following new sub rule 7(a) to be added.

"In case of equality of votes while carrying out election of office bearers, the polling should be carried out once again. In case there is still a stalemate of equality of votes, then the matter shall be decided by carrying out a lucky draw, which shall be carried out by a warden (not standing for election as an office bearer) who is acceptable to all contestants who have secured equal votes. Repolling will be done only for those who have secured equal votes and not all the contestants.

12 Sub rule 10(3) to be amended to read as follows:

"The Court shall have power to constitute a committee for attending to any of the affairs of the Company. A committee may consist of wardens and/ or members of the Company & shall be chaired by a member of the Court or a Past Master."

13 Rule 14 to be amended to read as follows:

14. RESOLUTION IN WRITING VALID

A resolution in writing signed by all Wardens for the time being or by circulation by any electronic or other accepted means, or by all members of any Committee of the Court, shall be as valid and effectual as if it had been passed at a meeting of the Court or of the Committee, as the case may be duly convened and constituted.

- 14 Rule 15 to be deleted
- Rule 18(2) (a) to be amended as follows:
- (a) The Court may from time to time determine the quorum necessary for the transaction of its business and unless otherwise determined by a regulation of the Court under Para 10.2, eight shall be the quorum.
- 16 Rule 18(3)(a) to be amended to read as:

On the request of the Master, or the Deputy Master or any eight Wardens, the Secretary General shall summon a meeting of the Court by a notice served upon the Wardens thereof and stating the proposed object of such meeting. The period of notice for such meetings shall be not less than seven days. Such notice may be sent to their registered address.

"Notices of general meeting shall be sent to the registered address of the members"

BOARD OF EXAMINATIONS FOR SEAFARERS TRUST (BES)

Report on activities of BES Trust for Financial Year 2021-22

1. General Purpose Rating & Certificate Course for Marine Catering Examinations:

- a) Board of Examinations for Seafarers Trust has been conducting Exit Examinations for GP and "Certificate Course in Maritime Catering" (CCMC) Ratings since 2006. It holds two exit examinations for fresh candidates and four exit examinations for repeater candidates in a year. The exit examinations for fresh candidates are being held in June and December and for repeater candidates in March, June, September and December respectively. Presently, there are a total of 54 GP and CCMC institutes all over India.
- b) During the year 2021-22, BES Trust could not carry out all the six examinations due to the restrictions imposed by the Government in light of COVID-19. BES was able to complete the exit examinations for ratings only in February 2022 who had taken admission in January 2021. The results were declared on 23rd February 2022 with a success rate of 74 % for GP and 89 % for CCMC candidates respectively. BES is still in continuation of conducting the exit examinations for ratings who had been admitted in July 2022. BES has received 912 application forms from GP and 60 from CCMC repeater candidates for the March 2022 examinations.

2. Inland Vessel Examinations:

- a) BES Trust had been regularly conducting examinations as per Inland Vessel Act on behalf of Maharashtra Maritime Board (MMB), Andhra Pradesh Maritime Board (APMB), Inland Water Transport Department (IWT), West Bengal and Directorate of Ports (DoP), Karnataka.
- b) In addition to State Maritime Boards and Directorate of Ports, BES also conducts examinations for Major Port Trusts such as Cochin, Chennai and Visakhapatnam under its respective Harbor Craft Rules.
- c) During the entire year, BES could hold only one examination for marine crew of Cochin Port Trust due to the pandemic. Out of 150 crew appeared, 87 passed bringing the passing percentage to 58.
- d) Although BES had assessed 680 Application Forms of IWT, West Bengal, could not carry out the examinations due to postponement of examinations by IWT in light of Covid-19.
- e) BES received a total of 799 Applications Forms from Maharashtra Maritime Board (MMB) inland vessel crew for appearing the examinations.

3. Distribution of Training Record Books for Ratings:

 a) BES Trust has been entrusted with the responsibility to distribute Training Record Books (TRB) to Indian Ratings by D.G. Shipping. During the year 2021-22, BES Trust distributed TRBs to various categories of Ratings as per the following:

• Deck Side Rating (Able Seafarer): 2684 nos.

• Engine Side Rating (Able Seafarer): 1839 nos.

• Electro-Technical Rating : 34 nos.

4. Seafarers Enhancement Program :

 a) BES exhausted funds received from Maritime Training Trust (MMT) in March 2020 and had requested for release of fresh funds in order to resume conduct of the programme.
 MTT could not release the funds due to the pandemic.

5. Hard Skill Program for fitters and Cooks:

10) Report on activities of BES Trust for Financial Year 2020-21

General Purpose Rating (GP) & Certificate for Marine Catering Examinations (CCMC): Board of Examinations for Seafarers Trust has been conducting Exit Examinations for GP and CCMC Ratings since 2006. Presently, there are a total of 48 institutes all over India. During the year, BES was required to conduct the exit examination in the month of June 2020 for the ratings who had taken admission in these institutes in the month of January 2020. But, due to the pandemic, the institutes were asked by DGS to close down in the month of March 2020. Hence, BES could not hold the exit examination scheduled in June 2020. DGS had to also, cancel admission of July to December 2020 batch of candidates who were supposed to get enrolled into the courses in the month of July 2020 in light of GS ordered opening up the training for the ratings of the pre-sea institutes in the month of November 2020 in phased manner allowing only 1/3rd of batch strength in the campus at any time. The training institutes divided their batches and resumed training. BES carried out the exit examination for the ratings as they completed their training in an institute. There are a total of 102 divided batches of candidates who are required to be examined. BES held the exit examination for 96 divided batches of 42 institutes as on 28th February 2021. BES proposed to DGS for declaration of results in two phases as the completion of examinations was taking long time for the entire batch strength of an institute. BES prepared the 1st phase results for the candidates of 42 institutes that had completed the examination and submitted the same to DGS for declaration on 22.03.2021. DGS published the results on their Website on 31.03.2021.

BES continued holding the exit examination of 4 more institutes in March 2021 when they reported their readiness.

March 2020 repeaters' examination was also held along with the fresh candidates. Their results

Were also prepared and submitted to DGS on 22.03.2021 along with the phase 1 results of fresh candidates. During the year of 2020-21, only one exit examination was held partly for the fresh candidates and one fully for the repeater candidates due to Covid-19
