ACTIVITIES OF BES TRUST FOR FINANCIAL YEAR 2**

3. Distribution of Training Record Books for Ratings:

- a) BES Trust has been printing and distributing Training Record Books (TRB) to Indian Ratings. During the year 2025-26, BES Trust distributed TRBs to various categories of Ratings as per the following:
- Deck Side Rating (Able Seafarer): 5265 nos.
 - Engine Side Rating (Able Seafarer): 3131 nos.
 - Electro-Technical Rating: 338 nos.

4. Seafarers Enhancement Programme:

- a) BES has been conducting SEP for Ratings/cadets. During the year, 24 training programs were conducted wherein 574 candidates participated.
5. BES had, in the year 2023-2024, embarked upon completely digitizing the examination process. We have been issuing digitized Admit cards and All India Exit Examination pass certificates since Dec 2023 examinations. The digitization is complete and we are now proceeding towards 'STQC Certification' of the developed system.
6. Structured Ship board Training Programme (SSTP)- Subsequent to the DGS approval vide File. No. 25-13011/1/2024-NT-DGS dated 19.3.2025, the BES has commenced the SSTP for NCV Deck Cadets. Till date, 65 candidates are enrolled in the programme. All of these candidates are sponsored by various shipping companies. 12 candidates have submitted their 1st Semester journals which have been assessed by CEO and has been sent back to them with remarks.
