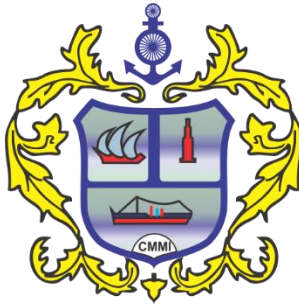

CMMI Mentoring Scheme

The **Mentoring Scheme**, launched by the **Company of Master Mariners of India (CMMI)** in **December 2020**, continues to progress steadily and has been widely appreciated within the maritime community. The scheme has seen a commendable response, with a dedicated team of **volunteer mentors** who have consistently demonstrated exceptional commitment and professionalism.

This initiative has proven to be **highly beneficial**, offering substantial support to junior professionals and cadets across both **professional and personal development domains**. Several **mentees have provided heartfelt feedback**, sharing how the guidance they received significantly enhanced their career trajectory, boosted their confidence, and provided clarity during critical decision-making phases. The positive impact of this program is increasingly evident across the industry.

As of now, the mentoring scheme proudly engages **49 experienced mentors** and supports **90 mentees**, with numbers steadily growing. The initiative exemplifies CMMI's ongoing commitment to nurturing future leaders of the maritime sector and fostering a culture of knowledge transfer, support, and community.

MOU Between BES and eSEHAT for DGS Examination Digitization Project.

The BES received a proposal to form a consortium with M/s eSEHAT, following the MoU signed on 19 January 2024.

1. This consortium aims to enable **eSEHAT** to respond to the **upcoming RFP** from **DG Shipping**, which intends to appoint a **System Integrator** for a unified virtual examination platform.
2. DG Shipping's initiative will integrate all **competency exams**, **STCW modular course exams**, and **BES exams** under a single digital platform.
3. **eSEHAT** has been actively working with BES since **September 2023** on the **Digitisation of Examination Process** project. Certificates for the **December 2023 All India Exit Exam** are being generated and uploaded; full deployment is targeted for **June 2024**.
4. This initiative presents a strategic opportunity for **CMMI and IME(I)**—via BES—to take a leading role in shaping the future examination systems for Indian seafarers.
5. BES is well-positioned and authorized (as per its Trust objectives) to act as a **System Integrator**, bringing domain expertise in examination management.
6. Failure to act now could result in a non-maritime entity leading this critical process, potentially compromising maritime-specific standards and oversight.

POLICY RESEARCH CELL WITH IMU-

The collaborative initiative between CMMI and the Indian Maritime University (IMU) under the Policy Research Cell, CPRiMeS, held two productive meetings during 2023–24, with participation from NIAS and RIC. Among several areas of mutual interest, CMMI has been invited to contribute to a new joint endeavour — I-ESKIMO (IMU Enhanced Student Knowledge toward IMO).

This initiative engages Heads of Departments across IMU's various schools and actively involves students in a structured competition, culminating in a final event scheduled for November 2024.

IMU serves as the knowledge partner to the Ministry of Ports, Shipping and Waterways (MoPSW), particularly in alignment with the Maritime India Vision (MIV) 2030. Once the foundational framework for I-ESKIMO is in place, CMMI will also formally join as a knowledge partner in support of this forward-looking academic and policy-driven initiative.

CMMI - IMO DELEGATE - CAPT. PANKAJ SARIN

ISWG - STCW 1 session held from 7th Oct to 11th Oct. 2024.

Brief: HTW Subcommittee Meeting and Court Deliberation Presentation by Capt. Pankaj Sarin

Capt. Pankaj Sarin briefed the Court on the outcomes of the ISWG meeting at IMO, London, particularly the proposal by several countries to reduce the 12-month sea-time requirement for 2nd Mates to 6 months, complemented by 6 months of simulator training.

Key Observations:

- Majority inputs, including those from DG Shipping and Capt. C.L. Dubey, oppose any reduction below 12 months.
- Capt. Philip Mathews supported retaining 12 months but advised a strategic, balanced approach—possibly suggesting limited simulator-based remission (15–30 days) to address unemployment and berth shortages.
- Capt. S.M. Halbe emphasized the need for a formal, professional stance from CMMI, not reliant on individual inputs alone.

Action Taken:

- A committee has been formed to deliberate and finalize CMMI's position, comprising: Capt. C.L. Dubey (Chair), Capt. M.P. Bhasin, Capt. Ajay Gangaadharan, Capt. S.M. Halbe, Capt. Philip Mathews, and Capt. P. Sarin.
- The Court agreed to communicate CMMI's consolidated stance to DG Shipping for upcoming IMO discussions.

The notice pertains to the reopening of the assessment on technical grounds, wherein the department has alleged under-assessment of income to the tune of Rs. 1,39,88,391/-, leading to a tax impact of Rs. 51,78,179/-.

Based on the advice from our accounting firm, UBR Legal, and after due deliberation, it has been resolved that this matter is fit for challenging through a writ petition in the Bombay High Court with a prayer to quash the proceedings initiated by the Income Tax Department.

- The scheme is permitted under Paras 3(15) and 3(16) of the Objects of the Company.
- A nominal one-time administration fee will be charged to cadets who join under this scheme.
